## Open Recruitment Announcement for **Prosecutor Instructors** to Support the Work of the Sexual Assault Training Institute

---

The Oregon Sexual Assault Task Force's (SATF) Sexual Assault Training Institute (SATI) is **recruiting prosecutors with expertise prosecuting adolescent and adult sexual assault cases to serve as instructors**. Since its first training in January 2003, the SATI has conducted basic and advanced sexual assault prosecution training throughout Oregon and nationwide. Our training includes best practices for prosecuting adult and adolescent sexual assault cases, including working with victims who have experienced trauma, partnering with law enforcement, sexual assault nurse examiners (SANEs), victim advocates, and others who may be involved in sexual assault cases.

Prosecutor instructors may also be asked to assist in training for active and sworn law enforcement officers, Sexual Assault Nurse Examiners, and Victim Advocates from time to time. SATF's SATI training for law enforcement, prosecutors, and sexual assault response teams is supported by federal Stop Violence Against Women Act (Stop VAWA) funds administered through the Oregon Department of Justice's Crime Victim and Survivor Services Division (CVSSD).

**Instructors will be expected to participate in curriculum development and reviews, which may include instructor workdays (virtual or in person), and will provide instruction in the delivery of training across Oregon..**

### **Qualified applicants will have:**

- a minimum of five years of work experience as an attorney;
- a minimum of two years of experience prosecuting adult and adolescent sexual assault cases; and,

- Preference will be given to applicants who also have experience providing instruction, conducting training and/or public speaking.
- Qualified applicants must complete and pass a criminal history check.

Oregon SATF commits to inclusive excellence by advancing equity, diversity, and inclusion in our programs. We are an Affirmative Action/Equal Opportunity employer, and enthusiastically encourage applications from members of historically marginalized racial and ethnic groups, women, individuals with disabilities, veterans, LGBTQIA2S+ community members, and those with historically under-resourced identities to help us achieve our vision of a diverse and inclusive working community.

### **What to expect in the application process:**

SATF will contact qualified applicants in order to schedule a virtual conversation and interview. The intent of this conversation is for SATF to learn more about the applicants' interest, approach to training and facilitation, and availability to collaborate as a SATI Instructor over the course of the coming year. Applicants' will also have an opportunity to learn more about SATF's values and approach to sexual violence response and prevention and ensure that the relationship is a good fit for both parties.

Selected candidates will be offered a one-year contract. Prosecutor Instructors are paid \$50.00/hour for each SATF approved hour spent on curriculum development, review, and training facilitation. Contractors and instructors are not regular employees of SATF and are not eligible for employee benefits, but are eligible for mileage and lodging reimbursement when travel is required for in-person work or training facilitation.
